3. Essence of Information Ethics

3.1. General Essence of Information Ethics

There are four points of view in the field of philosophy: (1) Information is the characteristics of mental entities. (2) Information is common adjunct of bodies. Obviously, we should first discuss the definition and meaning of information. Shannon considers that information is the thing used to reduce the random uncertainty. The definition does not include the content and value of information, and does not answered basically what is information. Wiener believes that information is the name of content exchanged with the outside world in the process of adaptation and reaction in the outside world. The definition contains the content and value of information. but some limitation exists because of exchange fuzzy. Because when people interact with the outside world, there are exchanges of matter and energy at the same time. Therefore, information is the result of the interaction of things, the performance of the result is exchanges of the content between things, the role of the exchanges is eliminating the state of uncertainty in the interaction of things. It is now clear that the essence and phenomena of things is not information, general essence of information is the state changes in the interaction of things.

3.2. Special Essence of Information Ethics

Special essence is the second highest level with conditional constraints, and it can be called the epistemological level. Wiener believes that information is the name of content exchanged with the outside world in the process of adaptation and reaction in the outside world. He ignored what is the purpose of adapting and exchanging with the outside From world. the way of human's understanding and expression, information can be found that it is being used to grasp the shape and status of things outside world in social life practice in order to adapt to achieve the state of knowledge of information source. That is to say, exchanging with the outside world means knowledge on nature and other individuals, and it is the interaction of knowing your enemy and knowing yourself. Information shows the effectiveness of knowledge by the way of exchange and it achieves interests of human survival contained in information in social life practice. The objective purpose obtaining and using information is not to own in the abstract, abstractly remove the random uncertainty, but to survive, grow and develop in real cruel, fierce living environment. Therefore, we can regard the special essence of information in the practice level as the ethical essence of information.

4. The future trends of Information Ethics

With the development of information society, a variety of practical ethical problems during information activities are becoming increasingly numerous and visible. A lot of the information ethical practice will significantly promote the innovation and development of the theory of information ethics. Globally, information ethics will be presented multicultural development. Information ethics will show the following trends: the integration of computer ethics, network ethics and information ethics net; the information ethics based on new information technology applications; the information ethics integrated multi-disciplinary theory and methods; the empirical research solved important information ethics issues; the establishment of unique national information ethics system; the comparative study on information ethics in the oriental and occidental cultural environment; the global information ethics research in global information trend.
