A Hybrid Deep Learning Approach for COVID-19 Diagnosis via **CT and X-Ray Medical Images** 2

A	bstract: COVID-19 pandemic is a global health problem since December 2019. Up to date, the total
nι	umber of confirmed, recovered and deaths has exponentially increased on daily basis worldwide.
In	this paper, a hybrid deep learning approach is proposed to directly classify the COVID-19 disease
fr	om both chest X-ray (CXR) and CT images. Two AI-based deep learning models, namely ResNet50
ar	od EfficientNetB0 are adopted and trained using both cheet X-ray and CT images. The public da-

JetB0, are adopted and trained using both chest X-ray and CT images. The public da tasets consist of 7,863 and 2,613 chest X-ray and CT images are respectively used to deploy, train,

and evaluate the proposed deep learning models. The deep learning model of EfficientNet always 19 performed a better classification result achieving overall diagnosis accuracies of 99.36% and 99.23% 20 using CXR and CT images, respectively. For the hybrid AI-based model, the overall classification 21 accuracy of 99.58% is achieved. The proposed hybrid deep learning system seems to be trust worth 22 and reliable for assisting health care systems, patients, and physicians. 23

1. Introduction

The outbreak of COVID-19 is considered as epidemic and pandemic affecting peo-27 ple around the world in a short period. It is rapidly transmitted among people in dif-28 ferent local and global communities due to the traveling issues [1]. Up to date, the 29 number of confirmed and death cases reaches to 226M and 4M worldwide, respec-30 tively. COVID- 19 is a novel coronavirus coined as Severe Acute Respiratory Syndrome 31 Coronavirus 2 (SARS-CoV-2) and it targets the human respiratory system. The con-32 firmed biological symptoms of COVID-19 are fever, shortness of breath, dizziness, 33 cough, headache, sore throat, fatigue, and muscle pain. Accurate and rapid classifica-34 tion technique become necessary to automatically diagnose the COVID-19 disease es-35 pecially in a pandemic situation. Recently, AI techniques (deep learning and machine 36 learning) were employed and to build a robust decision-making system against 37 COVID disease [2][3][4]. Traditionally, the COVID screening involves RT-PCR (Re-38 verse Transcription Polymerase Chain Reaction) carried out at the Pathogen labora-39 tory. Due to its higher time consumption and lower sensitivity, medical imaging tech-40

niques such as computed tomography (CT) as well as Chest X-Ray (Radiological Im-1 age) Images are being used to fight and classify the COVID-19 respiratory disease 2 [5][6][7]. The Lungs are the major target of the COVID-19 virus. RT-PCR is useful for 3 the diagnosis of disease whereas, CT and CXR images are useful to assess the damage 4 caused to the lungs due to COVID-19 at various stages of the disease. Inflammation of 5 lung tissues can be identified based size and shape of attacked tissues with the help of 6 X-Ray and CT images [6][3]. Deep ConvNets are extensively utilized in the fields of 7 hyperspectral images, microscopic images, and medical image analysis, In current 8 trending coronavirus-related diagnostic studies also used deep learning-based archi-9 tectures, were proposed namely COVID-SDNet, DL-CRC, and EDL-COVID [6][8][1]. 10 Machine learning-based techniques like SOM-LWL, PB-OCSVM, and one-shot cluster-11 based approaches for COVID CXR images have also introduced the diagnosis of 12 COVID detection and classification [9][10][11]. Also, there were other techniques like 13 transfer and learning methods were implemented using MobileNet, VGG, ResNet, 14 Alexnet, and Densenet architectures as a base module for training for the task of 15 COVID image classification [12][13]. Computer-Aided Diagnosis systems have been 16 proposed for several medical image analysis tasks like Breast cancer, Brain Tumor, kid-17 ney and Lung disorders using deep learning methods [14][15][12][5]. 18 In this proposed work, a hybrid deep learning system is deployed to perform classifi-19 cation task of COVID-19 using two CXR and CT datasets. Indeed, DeepConvNet's have 20 a promising feature extraction way to automatically identify a huge deep features di-21 rectly from the input images. Thus, overall classification accuracy could be improved. 22 The objective of this study is to provide a unified deep learning model using both med-23 ical CXR and CT images. The main contributions in this hybrid system are summarized 24 as follows. First, build a novel hybrid deep learning model in unified architecture to 25 automatically and rapidly classify COVID-19 disease using both CXR and CT images. 26 Second, deep learning regularizations of data balancing, transfer learning-based ap-27 proaches, and data augmentation are used for improving the overall diagnostic per-28 formance. Such these experiments will help to understand COVID-19 disease and di-29 agnose it using different medical imaging modalities [32][33][34][35][36][37]. 30 The objective of this work is to provide an AI-based robust and feasible system for 31 medical institutions, health care service providers, physicians, and patients by provid-32 ing practical solutions for COVID-19 diagnosis. 33 The rest of this paper is organized as follows. A review of the relevant literature is 34 presented in Section 2. The technical aspects of the deep learning methods for classifi-35

cation systems are detailed in Section 3. The results of the experiment with COVID-19 36 are reported and discussed in Sections 4 and 5. Finally, the most important findings of 37 this work are summarized in conclusion Section 6. 38

2. Related work

In early 2020 while the world was under a pandemic situation due to the COVID- 40 19 outbreak, Some Computer-Aided Diagnosis systems have been proposed based on 41 deep learning were introduced to predict COVID-19 on digital X-Ray and CT-Images. 42

In [18], Yang et al. Presented diagnosis of COVID-19 with the help of CT images and 1 proposed an AI-based diagnosis system based on DensNet and ResNet pre-trained 2 models with transfer and learning technique to classify and reported accuracy of 89%, 3 AUC of 98%, and F1-score 90% and dataset have made opensource. Madallah Al-4 ruwaili et al. in [19] used an improved Inception-ResNetV2 to Diagnosis COVID-19 in 5 x-Ray images which have got high accuracy in Radiography Dataset to detect COVID-6 19. Mundher et al. In [13] designed a model to Detect COVID-19 from X-Ray Images 7 Using Convolutional Neural Networks with transfer learning-based techniques with 8 VGG16 and MobileNet modules reported the highest accuracy of 98.28%. with VGG16 9 as a base model. In [19] Madallah Alruwaili et al. used an improved Inception-Res-10 NetV2 to Diagnosis COVID-19 in X-Ray images. Xception, VGG16, InceptionV3, Res-11 Net50V2, MobileNetV2, ResNet101V2, and DenseNet121 models were used for exper-12 imentation and with CXR images with Inception-ResNetV2 model achieved of 99.8%. 13 In [20] Fareed Ahmad et al. design a deep learning model for detecting Coronavirus 14 using Chest X-Ray Images. They use different CNN models such as MobileNet, Incep-15 tionV3 and, ResNet50. The best was model is InceptionV3 which ash 95.75% and 16 91.47%, accuracy and F-Score respectively. In [5] Boran Sekeroglu et al. CNN model to 17 detect COVID-19 from Chest X-Ray Images Using available dataset. They used CNN 18 without pre-processing and a decreasing number of layers is capable of detecting 19 COVID-19 in a limited number of data and imbalanced, chest X-ray images with an 20 accuracy of 98.50%. In [21] Pramit Brata Chanda et al. implemented a new model to 21 diagnose COVID-19 using Chest X-ray. They used CNN Based Transfer Learning 22 Framework for the Classification task and reported an accuracy of 96.13%. In [22] Mu-23 bashir Rehman et al. deign a platform Monitoring System to detect and Diagnosis of 24 COVID-19 using breathe rate measurement. In [8] S. Tabik et al. contributed a new 25 open-source dataset, called COVIDGR-1.0. In their experiment, they designed a new 26 model to detect COVID-19 using X-Ray Images also helped in measuring severity. And 27 they reported the classification as Moderate and Severe 86.90% and 97.72% respec-28 tively on the basis CXR database. In [12] Wentao et al. presented a new model based 29 on deep learning for the diagnosis COVID-19 using CT images. The transfer learning 30 technique was achieved good accuracy of 98%. In [6] Sadman et al. proposed a deep 31 learning-based chest radiograph classification (DL-CRC) framework to distinguish 32 COVID-19 cases with high accuracy from two classes abnormal and normal. They Pre-33 sented a deep learning model called the DL-CRC framework with two-part the first is 34 the DARI algorithm and generic data augmentation accuracy of 93.94%. In [23] Khalid 35 M. Hosny et al. designed a hybrid model to detecting COVID-19 using two types of CT 36 scans and chest X-ray images. Their work combined two types of images to fit memory 37 and computational time. They proposed the framework for CXR and CT images with 38 99.3% and 93.2% respectively. In [7] presented transfer learning to detect COVID-19 39 using X-ray and CT Scan Images. It is because, in COVID-19, initial screening of chest 40 X-ray (CXR) may provide significant information in the detection of suspected COVID-41 19 cases. In [24] Ravi et al. presented the model to detect COVID-19 using both CT 42

and CXR datasets. In [25] Elmehdi Benmalek et al. aimed to make a comparison for the
performances of CT scan and chest X-ray image to detect COVID-19 pandemic utilizing
CNN and they got accuracy equal to 98.5% and 98.6%, respectively. In [16] Muhammad
E. H. et al. Presented a strong model to detect COVID-19 pneumonia using l chest Xray images utilizing the pre-trained deep-learning technique. They have created a database by merging data that has been created by previous work. They have got classification accuracy of 99.77%.

3. Methods and Materials




Figure 1. Schematic Hybrid deep learning diagram of the COVID-19 classification system.

The proposed hybrid deep learning system for COVID-19 diagnosis is demon-9 strated in Figure 1. Two different deep learning models, namely ResNet50 and 10 EfficientNetB, are used for CXR and CT images, respectively. Both deep learning mod-11 els are trained using 100 epochs. The last layers from both deep learning models are 12 concatenated together to merge the derived deep features and generate most single 13 robust deep feature set. This set carries a promising features generated from both CXR 14 and CT images in the same time. This is a key to improve the overall accuracy perfor-15 mance of the proposed deep learning system. Then, the concatenated deep features are 16 scaled in 1D form using a global average pooling (GAP). This is to make the derived 17 feature maps suitable for the following two fully connected layers. Finally, Softmax 18 layer is used to make the final decision regarding the output is a positive COVID-19 19 disease or a normal negative case. To reduce the overfitting that may occur during 20 training phase, the 0.5 dropout strategy is used. For pre-training, transfer leering strat-21 egy is used with ImageNet database. 22

The pre-processing technique is the most significant step of the model. Here, we consider raw data and transform it into specific input data format and dimension 2 [3][28][31]. We inculcate the data augmentation and class balancing strategy to reduce 3 the overfitting and this acts as a catalyst for the training process [15][31]. Later, we 4 divide both data into 70% for training, 20% for testing, 10% for validation. For each 5 class, the dataset is selected in a randomized manner. For hyper parameters initialization, transfer earning strategy is applied using the dataset of imageNet [3][15][31]. 7

3.2. Feature extraction

Deep CNN has shown improved performance regardless of domain namely medical 9 imaging, and generalization of the model has been observed. Transfer learning is being 10 explored to provide an efficient solution [6]. In our experimental analysis, we employ 11 ResNet50 [27] and EfficientNet [24][26] models for the task of feature generation, Deep 12 features are later passed to custom layers user-specific, in our work we push to global 13 average pooling followed by fully connected layer [24] we use 2 FC layers and improve 14 efficiency and to generalize learning also introduced Dropout in middle of FC layers. 15 These extracted features passed for the classification layer to assign the appropriate 16 class label of the given input data instance. 17

3.3. Classification

The pipeline of extracted deep features through feed-forward models ResNet and Ef-20ficintnets for feature extraction passed to SoftMax layer for classification. The results21were generated for both CT and CXR databases separately and results were discussed22in table 2 and table 3. The results were promising in contrast to existing works.23

4. Experimental analysis

4.1. Dataset

To quantify our work, two datasets of chest X-ray and CT are used. These datasets are 26 publically available at Kaggle databases [16][17][18]. The datasets are described as 27 shown in Table 1. 28

4.2. Implementation Environment

To perform all experiments in this study, we use a PC with the following specifications:31Intel R © Core(TM) i7-6850 K processor with 32 GB RAM, 3.360 GHz frequency GPUs32NVIDIA GeForce GTX1050Ti. Deep learning algorithms are implemented herein using33Python 3.8.0 programming with Anaconda [Jupyter notebook]. The Python-based ML34libraries such as Torch, TensorFlow, OpenCV, pandas, and Scikitlearn are utilized to35

investigate the performance metrics by the proposed methods at the same time TensorFlow and Keras in Colab have been used to implement Transfer learning. The results and discussions concerning various techniques incorporated are highlighted in the subsequent sections. The source codes were made available at GitHub¹.

4.3. Evaluation metrics

To assess our proposed system, we use the evaluation metrics of Recall/ Sensitivity7(Re), Specificity (Sp), F1-measure (F-M), and overall accuracy (Az). The mathematical8formula for these evaluation metrics are defined as follows,9

where TP, TN, FP, and FN are defined to represent the number of true positive, true
negative, false positive, and false negative detections, respectively. The confusion matrix is used to derive all of these parameters.

5. Results and discussion

This section shows our experimental results as in the following two different scenarios: 16 single straight forward scenario and hybrid scenario. Former scenario means both deep 17 learning models (i.e., ResNet50 and EfficientNetB) are separately used and tested to 18 investigate which model could provide the best overall classification accuracy for a 19 single dataset; chest X-ray or CT images. The later scenario means both deep learning 20 models are concatenated to produce the proposed hybridization model as shown in 21 Figure 1. This is to check which hybridization combination could achieve the best per-22 formance when both chest medical images are used. 23

5.1. Single Straight Forward Scenario

For each medical chest dataset (i.e., chest X-ray or CT images), two different experiments are performed. One experiment is done using the deep convolutional ResNet50 27 model and another one is perforemed using the EfficientNetB deep learning model. By 28 other words, the single deep learning model (i.e., ResNet50 or EfficientNetB) is trained 29 twice: on time for chest X-ray and another time for CT images. In both training styles, 30 same deep learning architecture as well as training/testing settings are used. 31

5.1.1. COVID-19 Classification based on Chest X-Ray Images In this case, the input dataset is only X-ray images for deep learning ResNet50 or EfficientNetB. The overall classification evaluation results are summarized in Table 2. Although it is obviously shown that both deep learning models achieve almost the same results, the EfficientNetB deep learning model achieves a slightly better overall accu-

5.1.2. COVID-19 Classification based on Chest CT Images

racy by 99.36%.

Chest CT dataset is only used to separately train the deep learning models of ResNet5011and EfficientNetB. The overall classification evaluation results are reported in Table 3.12The EfficientNetB deep learning model achieves a slightly better overall accuracy by1399.23%, while other evaluation metrics show the consist and stable performance.14

5.2. Hybrid scenario: COVID-19 classification using Chest and X-Ray Images

In the proposed hybrid deep learning model, both chest X-ray and CT datasets are used as19input as shown in Figure 1. The evaluation classification results for the best combination20hybrid model are demonstrated in Table 4. Each row in Table 4 presents the classification21assessment results by using a single deep learning model in a hybrid style for both chest22X-Ray and CT images as well.23

6. Conclusion

A hybrid deep learning model is proposed to automatically detect COVID-19 respira-1 tory disease from both chest X-ray and CT images. The proposed hybrid model uses 2 two deep convolutional networks namely ResNet and EfficientNet to generate prom-3 ising deep hierarchical features. The proposed hybrid deep learning approach could 4 achieve classification accuracies of 99.58% using chest X-ray and CT images. Further 5 improvements could be achieved by including ultrasound images as well. This is to 6 construct and build much robust and reliable diagnosis system to fight COVID-19 in 7 early stages. The promising results seem to be helpful to provide a better real-time 8 diagnosis system for health care service providers, physicians, and patients. 9
