



Proceeding Paper Conception of a Control and Management System Lighting with Graphical User Interface ⁺

Abstract: Lighting is the largest item of electricity consumption. The implementation of new technologies makes it possible to reduce the energy bill as well as the operating cost. In this work, we created a control and management system for the exterior lighting using creative, intelligent and autonomous methods. The project allows control room operators to monitor the system and interact when needed. Our project is subdivided into three major parts, ordering, data processing, and action. The first part is carried out in two modes, manual using an Optocoupler and controlled with a graphical interface by RS232 serial-type communication. The second is processed by a microcontroller, as for the third part, it does the action of controlling three poles through the MOC3023 Optotriac IC and BTA16-600B Triac for full and half lighting. For the controlled mode, we are going to use the dimmer principle works by essentially chopping parts out of the AC voltage. The brightness of the lamp is determined by the power transferred to it, so the more the waveform is chopped, the more it dims. A zero crossing control is needed for phase cutting. The graphical application of our project has a rather sketchy design. It is divided into two windows, the first consist connection window, and the second one is for the main control interface. On this control interface, there are basically three tabs, connection and serial connection status, control, and operating mode.

1. Introduction

Urban nightlife remained limited in the 18th century, and activity in the city stopped when the sun set. At night the streets become useless, no movement, and a place filled with crime, the streets and monuments of an unknown identity. Therefore, the need arose to research what makes life in the city at night similar to what it is during the day. To protect himself from the dangers of the night and ward off his ancestral fear of darkness.

Man responded by inventing public lighting, offering himself a reassuring environment and prolonged activity beyond nightfall. Public lighting has been set up for safety reasons, in general light allows individuals to move in space or defend them-selves and this requires a high level of lighting performance that meets standards and requires the rational use of energy [1]. So, how to adapt public lighting to needs while limiting the impact on the environment and electricity consumption?

In this simple project, we have established a start or a beginning step towards the efficient use and energy conservation by controlling and managing a lighting system from the comfort of one's desktop using two necessary components which are an electronic system, and a graphic user interface. We're aiming to make lighting system easily and controllable. This work is based on a practical implementation by using the Arduino card as a microcontroller and an HMI created by python tkinter interface on PC which supports the management of this system by a simple serial communication. In Section 3, our system description and schematic of the electronic circuit are presented, and in Section 4, the result and discussion are mentioned. Finally, in Section 5, the conclusion our present work is drawned.

2. Lighting and Smart Control Systems

Public lighting system is generally roadway lighting offering an improvement in the visibility. It is a set of lighting methods used in public places inside and outside the city, usually on the edges of roads, used to give a feeling of safety and contribute to the prevention of accidents. The lighting of outdoor spaces must adapt to the evolution of the political framework. It must respond to new environmental and energy challenges, while controlling the economic standards related to the total cost for a successful outdoor lighting installation [2].

One of the easiest ways to save energy is to turn off light fixtures located in unoccupied areas. The control of public lighting can be done in different ways, either by means of simple local switches, motion detectors, photoelectric cells, programmable clocks, or even using computerized lighting control systems [3].

There are four possible strategies for lighting control,

- Program the switching on and/or dimming times. For a system with reduced illumination, it is necessary to install dimmable lamps or two non-dimmable lamps per street lamp.
- Lighting of individual streetlights managed by motion detectors or presence detectors and with a programmable switch-off delay.
- Combination of programmed ignition, natural light function and/or motion detection. This option can be useful, for example, if you want to reduce the lighting intensity at night or only on request.
- Advanced systems that use software and hardware to automate the control of lighting in a building. Some of the benefits of computerized lighting control systems include the ability to monitor and control lighting usage in real-time.

3. System Description and Schematic of The Electronic Circuit

As pointed out above, our project is subdivided into three major parts, ordering, data processing, and action.




Figure 1. Electronic diagram of our card produced under EAGLE PCB software.

The first part is carried out in two modes, manual and controlled with a graphical interface. The second is processed by a microcontroller, an Aduino nano in our case. As for the third part, it does the action of controlling three poles via Optotriacs + Triac for full and half lighting. In order to make our light control system, different components have been used as well as a user interface is created. For the realization of our electronic card, and in order to prototype our electronic circuit in real Printed Circuit Board (PCB), we used the EAGLE PCB software [4] for the design of the printed circuit (Figure 1).

4. Results and Discussions

4.1. Manual and Command Mode Management

This project is supposed to be a two-mode lighting manager. A controlled mode via the graphical user interface performed with Python, and a manual mode directly organized within the switches. The idea of swinging between the two modes is to have a switch to toggle between the two modes.

The mode change button is very essential to launch the manual mode in case of concern in the controlled mode by Python via graphical interface.

4.2. Management of Optocoupler Inputs (Digital Inputs)

All the inputs/outputs of a microcontroller are electrically very fragile when it comes to connecting them to the outside world. The inputs-outputs available on the Arduino card must be handled with great care. The idea is to use galvanic isolation between the inputs of the microcontroller and the outside. In other words, there will be no electrical connection between the microcontroller and the external devices and the transfer of information will be done by light using an electronic component called Optocoupler.

In this present project, we will operate our light management and control system only on three poles. As we have already mentioned before, there are two modes of operation. The mode controlled by the graphical user interface that does not require Optocoupler inputs, because the microcontroller will be directly controlled by RS232 serial-type communication. The one that requires galvanic isolation is the manual mode. The electronic card of our system will be controlled by three switches, and to avoid any concern related to overvoltage of the inputs, we have protected our electronic card by Optocouplers.

As you can see on the wiring diagram of Figure 1, the 3 manual control switch inputs are connected to the discrete inputs of the electronic card using the 3-pin connector. In our system, the input of the Optocoupler (diode side) is controlled precisely like an LED. Resistors limits its current to around If =10mA. LED's are a current flow indicator light emitting diode. The Zener diodes, are placed for protection against overvoltage. Other resistors are a pull down resistors fixed state at LOW (LOW state) whose role is to ensure that the output of the Optocoupler (the input of the microcontroller) is at 0 V when the manual override switch, is not pressed.

4.3. Output Management with Triac

The outputs for our project are used to operate the three poles, either full or half. For manual mode, we preferred to turn all three poles on (full) or off. For the controlled mode, we are going to use the dimmer principle. A dimmer is an electronic device designed to regulate light output of incandescent and halogen lamps with special dimming ballasts. A light dimmer works by essentially chopping parts out of the AC voltage.

This allows only parts of the waveform to pass to the lamp. The brightness of the lamp is determined by the power transferred to it, so the more the waveform is chopped, the more it dims. The operation of the dimmer is based on the fact that, during a full cycle of an AC waveform, a Triac will only allow a part of the waveform to be delivered to the load (lamp). A first example that comes to mind is to connect one or more LEDs with the associated resistors, you should know that for this present microcontroller, the maximum current that a pin configured as an output can provide is only 16 mA and of 50 mA in total for all the IOs. We will therefore have to use a buffer or driver between the output pin and the load we want to connect. It will of course be necessary to choose the type of driver adapted to the load to be controlled. There are different possibilities for adding an output stage depending on what we want to control. For our part, we have chosen to use the famous ULN2803 driver, which is very responsive in controlling logic peripherals. This circuit serves as a power interface between the microcontroller outputs and the Optotriacs. The ULN2803 is an integrated circuit in DI format contains 8 driver circuits capable of circulating 500mA from our 5V power supply and incorporates anti-return diodes, which allows us to drive our three Optotriacs with complete peace of mind. The Triac output is driven by the ULN2803 via the MOC3023 random-phase Triac driver output Optocoupler (Figure 1).

4.4. Zero Crossing Control and Phase Cutting

The zero crossing is directly derived from the rectified mains AC lines — via an Optocoupler of course and gives a signal every time the wave goes through zero. Because the sine wave first goes through double phased rectification, the zero-crossing signal is given regardless whether the sinus wave goes up through zero or down through zero. This signal then can be used to trigger an interrupt in the microcontroller. The circuit mounted on our electronic board does exactly that. The mains 220Volt voltage is led through two 100k resistors to a bridge rectifier that gives a double phased rectified signal to a 4N35 Optocoupler. The signal of the 4N35 is fed to an interrupt pin in the microcontroller. Opening the Triac after a number of microseconds delay starting from the zero crossing therefore gives a predictable level of dimming.

When the voltage is 5 V, the current in the LED allows the conduction of the Optotriac T1 (see datashet for MOC3023 Optotriac). When T1 is conductive (it behaves almost like a wire), it controls the trigger T2 of the Triac. It is T2 which controls the mains load, like a switch. T1 is not "powerful" enough to drive the mains load directly, it only supports 100 mA, which would not satisfy many people. When the control voltage returns to 0 V, the Optotriac remains on until the cancellation of its current. Conduction therefore remains for the rest of the half period.

In this project only regular incandescent lamps are truly suitable for dimming. It will work with a halogen lamp as well, but it will shorten the life span of the halogen lamp. It will not work with any cfl lamps, unless they are specifically stated to be suited for a dimmer. The same goes for LED lamps. This mains load control by Triac and microcontroller can be reproduced in many copies to control several loads.

- All the A2 anodes of the power Triacs can be connected together (phase).
- All the bottom terminals of the loads can be connected together (neutral).




Figure 2. Lighting management and control project with all necessary elements.

4.5. Serial Communication

Generally, a microcontroller works at TTL of about 0 to 5 V while a computer operates on the standards of RS232 like –25 to +25 V. So interfacing a computer with a microcontroller is not possible without a dual driver/receiver IC. In our project, for connect our microcontroller to the serial we used the MAX232IC.

The MAX232 IC is widely used for serial communication among microcontrollers-PC. The main function of this integrated circuit is to change the logic levels of TTL/CMOS to RS232 throughout the serial communication process. The circuit built with the MAX232 IC and four exterior capacitors for producing maximum voltage internally. An Onboard 9 pin female D connects this MAX232 IC to the Serial Port cable. The DB9 Connector connects to the Host for power supply and serial In/Out signals.

4.6. Graphical User Interface

To carry out our practical realization, it was necessary to create a graphic interface in order to control the light in a controlled mode with a dimmer. So we first asked ourselves the question of how to do it, and what tools to use. In this project we use Python language, the tool that we used to create the graphical interface.




Figure 3. GUI screenshot using Python Tkinter for our project.

The graphical application of our project has a rather sketchy design. Without going through more details about the python code, our graphical interface is divided into two windows, the first is the connection window (Figure 2), and the second is the control interface (Figure 3). On this control interface, there are basically three tabs, connection and serial connection status, control, and operating mode.




Figure 4. Final card of our project, connection and test.
