PARTICIPATORY APPROACHES TO A NEW ETHICAL AND LEGAL FRAMEWORK FOR ICT

The Consortium meeting analyzes the first steps of PANELFIT.

PANELFIT project members organized the second Consortium meeting in Brussels at the end of May. Partners discussed the strategies of the different and varied actions included in this initiative, which aims to facilitate the implementation of the GDPR through operational standards and practical guidelines that reduce the problems of ICT technologies in legal and ethical aspects, especially from the perspective of privacy.

In addition to the confirmation of all documentation related to the project was delivered in time and form, an overview of the current status of the activities and work packages was carried out as well as planning the next steps.

Furthermore, a workshop on Governance of ICT Data Protection ELI was held, in which sufficient information was provided to generate the basis for the report. Questions about the structure and end-users of The Guidelines, the Dissemination tools, the organization of the first MOOCS and the Handbook for data journalists were also addressed.

The meeting also served to introduce the Workshops that would take place at the beginning of June in Bilbao.

NEWS Positive balance of PANELFIT Experts Workshops.

The expert workshop on governance of ICT data protection Ethical and Legal issues (ELI) took place in Brussels, on 22nd May 2019. Participants discussed the most important challenges in the area of ICT research and innovation. Stakeholders' opinion on what are the most important ethical and legal regulatory challenges related to data protection in the area of ICT research and innovation were stated, as well as the main options for action in this field.

Very successful were also the three workshops held in June at the University of the Basque Country UPV/EHU in Bilbao. The workshops were focused on the basic pillars of the project: Data Commercialization, Cybersecurity and Data Protection, with the objective of obtaining inputs for the gap analysis.

In the workshop on Data Commercialization, organized by the Goethe University of Frankfurt, the 6 expert speakers presented the papers made, generating an interesting debate that led to the exchange of ideas.

The following day took place the workshop on Cybersecurity in which the organizers, the Austrian Academy of Sciences (OEAW), proposed 3 blocks of questions about the gap in Cybersecurity and Data Protection issues to be answered in groups. A dynamic and participative working environment was created, with the participation of worldwide experts that enriched the debate.

On the third day at the Data Protection workshop there were 8 speakers who participated in 4 presentations, emphasizing vulnerable profiles and transparency, touching on issues of GDPR, risk analysis and informed consent. The session was organized by the Vrije Universiteit Brussel (VUB).

On August 2019 took place the SHERPA project Panel "Shaping the ethical dimensions of information technologies – a European perspective" in the frame of the IEEE Forum (Ethics and Human Rights in Smart Information Systems 2019). PANELFIT's coordinator professor Romeo Casabona attended to the meeting and presented the dissertation: "Legal responsibility of IA, robots and autonomous systems?"
